Nature of the event: *An application to certify a class action was filed concerning the collection of fees in foreign currency*

The First International Bank of Israel Ltd. ("the Bank") would like to report that on 13.09.2021 we received a statement of claim and an application to certify the same as a class action pursuant to the Class Actions Law, 5776-2006 (hereinafter both of them collectively: "the application"), the same having been filed against the Bank and four other banks.

According to the applicants, the Bank's fees, which are set in the price lists in foreign currency and not in Shekels, are unlawful, particularly when the collection of the fees is carried out by notional conversion into Shekels, at high conversion rates. Accordingly, so the applicants allege, the Bank should be required to refund to the class members all the amounts that were collected in respect of fees presented or stated in the price lists in foreign currency over the last 7 years. In the alternative, the Bank should be ordered to refund to the class members the conversion margins in respect of these fees.
