*The First International Bank of Israel Ltd. (hereafter - "the Bank") would like to report that it received a statement of claim and an application to certify the same as a class action pursuant to the Class Action Law, 5766-2006 (hereafter both of them collectively - "the application"), the same having been filed against the Bank and four other banks. According to the applicants, the amount of the action, against all the defendant banks, stands at NIS 984 million and according to them each month this amount increases by about NIS 104 million.*

*As alleged in the application, inter alia, the interest paid on deposits deposited through direct channels is lower than both the customary and accepted interest at the Bank and the interest paid at the Bank when depositing in the same deposit through a teller, without informing this to customers making deposits into the deposit through direct channels and without inviting them to negotiate this interest, as alleged by them, contrary to law.*
