The controlling shareholders of Harel Insurance Investments and Financial Services Ltd. are: Yair Hamberger (ID No. 007048671), Gidon Hamberger (ID No. 007048663) and Nurit Manor (ID No. 051171312). The holdings of the controlling shareholders in the holder are held primarily through GYN Financial Services and Investment Management 2017 Limited Partnership (Partnership No. 550272587) - a partnership controlled and wholly owned by the controlling shareholders, which they hold as limited partners - and through private companies which are wholly owned by them.

Note regarding section 3.b:

The holdings appearing under the category provident funds include direct holdings of the security held by the provident funds (0 nominal value) and holdings of the "Harel Amitim Israel Shares" partnership (hereafter: "the Partnership"), in the amount of 3,600,161.40 nominal value.

The Partnership is a partnership registered with the Partnerships Registrar, and all owners of the rights therein are members in the Harel Group institutional reporting group. The Partnership itself is not a provident fund management company. In accordance with the partnership agreement among the owners of the rights in the Partnership, the following are the holdings in the Partnership, as of 10 January 2021: Mivtach – Profit Sharing (35.05%); Provident Funds (64.95%).
