In accordance with the Securities (Immediate and Periodic Reports) Regulations, 5730-1970, the First International Bank of Israel Ltd. (hereafter - "the Bank") would like to report that on 05.06.23 we received a statement of claim and an application to certify the same as a class action pursuant to the Class Action Law, 5766-2006 (hereafter both of them collectively - "the application"), the same having been filed against the Bank and three other banks.

As alleged in the application, failure to grant automatic credit interest on credit balances in current bank accounts, and this either by way of granting direct interest and/or by way of making a deposit with daily interest automatically or in any other manner, and failure to inform customers regarding their suitable options in the case of a credit balance in a current account, constitutes a violation of various provisions of law and of the duty of disclosure and unjust enrichment.

The total relief sought in the application is compensation estimated at this stage in an amount exceeding NIS 1 billion.

The represented class is defined as account holders who had credit balances in the amounts and time periods specified in the application, as of the month of April 2022 onwards.
